8. STEPS March Challenge: Go Lean with Protein

Protein builds and maintains muscles, is responsible for healthy blood cells and strengthening the immune system. Focus on lean protein choices (animal or plant based.) Award yourself three (3) points for every time you choose a lean protein instead of a higher-fat alternative. Consider foods like turkey, fish, chicken, beans, tofu, etc. At the end of the month, be sure to add up your points and enter them online at www.schoolnutrition.org/STEPS – you could win a prize!

To use the [Block Grant Calculator](#):

- Complete the green fields.
- Part one shows immediate loss of funds to your program.
- Part two shows percent decrease in funds over three years.
- Part three shows the cumulative losses over three years.

11. USDA Extends Food Crediting in Child Nutrition Programs Comment Period

In a [Federal Register Notice](#) published on February 17, 2018, the U.S. Department of Agriculture (USDA) Food and Nutrition Service (FNS) announced that they were extending the comment period for the Food Crediting in Child Nutrition Programs: Request for Information (RFI). The information collection, as previously reported in *Tuesday Morning*, intended to help FNS gather feedback from stakeholders on how the crediting system can be improved, as well as to offer customer service to those operating and benefitting from the Child Nutrition Programs (CNP). The new due date for comments is April 23, 2018, and can be submitted through the [Federal Register](#).
